

CONSERVANCIES WAIVER AND RELEASE OF LIABILITY FORM

I, _____ an adult of sound mind, Parent/Guardian, acting on my own behalf and on behalf of the Minor(s) named below, hereby agrees and acknowledge as follows:

1. I am visiting and/or staying in **Enonkishu, Lemek, Mara North, or Ol Chorro Conservancies**, a private wildlife conservancy owned and operated by one of the following: **Kileleoni Limited (Enonkishu), Old Boma Limited (Lemek), Mara North Holdings (Mara North), or Ol Chorro Oirowua Conservancy Limited (Ol Chorro)** for the 2026 UltraMARathon organised by Ultra Marathon Company Limited by Guarantee.
2. I fully understand that as a visitor and/or guest in **Enonkishu, Lemek, Mara North, or Ol Chorro Conservancies** there exists element of risk during any day trip, overnight stay, or while doing research and other activities including walking, running, jogging, horse riding, camping and/or any other excursions.
3. I fully understand and accept that there are dangerous animals present in **Enonkishu, Lemek, Mara North, and Ol Chorro Conservancies** that are capable of causing me bodily harm and possibly death.
4. I understand and acknowledge all the risks associated with my visit and/or stay in **Enonkishu, Lemek, Mara North, or Ol Chorro Conservancies** and I agree on my behalf and of any minors accompanying me to **WAIVE, RELEASE AND DISCHARGE Kileleoni Limited (Enonkishu), Old Boma Limited (Lemek), Mara North Holdings (Mara North), and Ol Chorro Oirowua Conservancy Limited (Ol Chorro)**, its directors, shareholders, employees, agents, affiliates, trustees and officers from any liability, including but not limited to liability arising from the gross negligence or fault of the entities or persons released except to the extent caused by the gross negligence or wilful misconduct of the released parties, arising from the consequences of any personal injury (fatal or otherwise), death, disability, accidents, claims, delays, losses and loss of or damage to personal property or action of any kind which might occur to me during my visit and/or stay in **Enonkishu, Lemek, Mara North, or Ol Chorro Conservancies**.

5. I shall indemnify, hold harmless and undertake not to sue **Kileleoni Limited (Enonkishu), Old Boma Limited (Lemek), Mara North Holdings (Mara North), or Ol Chorro Oirowua Conservancy Limited (Ol Chorro)** from any and all liabilities or claims made as a result of my visit or stay in **Enonkishu, Lemek, Mara North, or Ol Chorro Conservancies**, whether caused by the negligence of **Enonkishu, Lemek, Mara North, or Ol Chorro Conservancies**.

6. I acknowledge that **Kileleoni Limited (Enonkishu), Old Boma Limited (Lemek), Mara North Holdings (Mara North), or Ol Chorro Oirowua Conservancy Limited (Ol Chorro)** are **NOT** responsible for any errors, omissions, acts or failures to act of any party or entity conducting a specific activity on their behalf. I shall bear all medical costs and expenses in relation to any medical assistance required during my stay or visit and shall reimburse **Kileleoni Limited (Enonkishu), Old Boma Limited (Lemek), Mara North Holdings (Mara North), or Ol Chorro Oirowua Conservancy Limited (Ol Chorro)** of any expense payments made for the provision of any medical assistance required by me. This indemnity and reimbursement obligations applies equally to any medical costs incurred for myself or any Minor accompanying me.

7. I accept responsibility for entering **Enonkishu, Lemek, Mara North, or Ol Chorro Conservancies** and accept any risk or damage to my person and of any minors accompanying me or their or my property.

I waive any and all claims and my right to sue **Kileleoni Limited (Enonkishu), Old Boma Limited (Lemek), Mara North Holdings (Mara North), or Ol Chorro Oirowua Conservancy Limited (Ol Chorro)**, its directors, shareholders, employees, agents, affiliates and officers on account of any injury, accident, claim, loss, liability or damage.

9. I certify and confirm that I have read and fully understood this document and accept that this Waiver and Release of Liability is binding on me and on each Minor named below and shall at all times be governed by Kenyan law.
